Promotional Period

1. Seagulls Club (Seagulls) "We're Going Paperless" promotion ("Promotion") commences at 10am on Monday 22 February and ends 5pm Wednesday 31 March 2021.

Entry Requirements

2. Entry is open to all financial members of Seagulls.
3. Members must complete the 'Update your details' form online to be eligible. The form is also available on the iPads at reception. Entry must include a valid mobile and email address to be valid.

Draws & Prizes

4. All draws will be conducted at 5pm Wednesday 31 March.
5. There will be 5 x \$100 Lot Two voucher draws plus a major draw with 3 winners receiving \$500 cash each!
6. Five x \$100 Lot Two voucher draws will be conducted first, followed by the major prize draw.
7. The winners do not have to be present and can claim their prize on their next visit to seagulls.

Identification
