Promotional Period

1. The “Seagulls 60K Saturday” promotion (“Promotion”) commences at 10am Monday 3 January and ends after the last draw Saturday 25 June, 2022.

Entry Requirements

1. All financial members are automatically entered into the draw.
2. The winning member must be present at the time of the draw.
3. The winning member has 4 minutes to present him/herself to the Promotional Host to claim the prize.

HOW IT WORKS

- There will be one membership draw on the last Saturday of each month.
- There will be 5 badge draws each night.
- Draws will commence at 6:30pm and will be conducted every half hour commencing until 9.30pm.
- **If a winner has not been found by 9:30pm the Promotional host will attempt a draw every 5 minutes up until 10pm. If a winner is still not found then the \$10,000 prize will be shared among 5 members randomly drawn from the checked in members list.
